**1. ACKNOWLEDGMENT AND ACCEPTANCE OF TERMS**

This Privacy Statement sets forth our current privacy practices with regard to the information we collect when you become a member of RRPOA ("member") or visit River Ranch Acres through RRPOA's gate ("visitor"). By becoming a member or visitor, you acknowledge and fully understand RRPOA's Privacy Statement and freely consent to the information collection and use practices described in this Privacy Statement.

**2. INFORMATION WE COLLECT AND HOW WE USE IT**

RRPOA collects certain information from and about members and visitors from Membership Applications, Membership Agreements, Conservation Easements, and Waiver of Liability, Hold Harmless Agreement and Consent to Medical Treatment Forms.

When members and visitors complete a Membership Application, Membership Agreement, Conservation Easement, and/or Waiver of Liability, Hold Harmless Agreement and Consent to Medical Treatment Forms, we request some personal information such as name, address, email, telephone number, River Ranch Acre folio number and other relevant information. If you make any purchases at RRPOA by credit card, this information may be forwarded to your credit card provider.

We will not disclose personally identifiable information we collect from you to third parties without your permission except to the extent necessary including:

- To fulfill the terms and conditions of the Membership Agreement
- To protect ourselves from liability,
- To respond to legal process or comply with law, and/or
- For officers and directors of RRPOA to communicate with members and visitors from their district.
